### A Resolution to Increase Student Accessibility on Campus

**Whereas;** the University of North Alabama Student Government Association recognizes the need for more adequate and compatible accessibility and infrastructure on campus to all students no matter the demographic; and

**Whereas;** the Student Government Association has partnered with UNA Facilities and the UNA Aubrey and Annie Looney Disability Support Services office in an effort to improve accessibility and infrastructure on campus; and

**Whereas;** the Student Government Association completed a campus wide classroom audit and submission of UNA Facilities work orders, to ensure that there is adequate accessible seating within classrooms on campus, restored infrastructure, and maintained communication with Kendra White, Director of Facilities Administration & Campus Support Services; and

**Whereas;** the Student Government Association will strive to continue working towards this initiative by continuing communication with UNA Facilities regarding the completion of work orders submitted during the 2025-2026 administration. The work orders consist of updates to accessible seating in classrooms and restoring damage to classroom infrastructure; and

**Whereas;** the Student Welfare Committee strives towards better accessibility with the completion of a campus wide audit and submission of UNA Facilities work orders, as well as drafting accessible map routes, and staying in communication with the UNA Disability Support Services office and UNA Facilities; and

**Whereas;** the Student Welfare Committee will continue working towards this initiative by continuing communication with UNA Facilities regarding completion of work orders submitted during the 2025-2026 administration. The work orders consisted of updates to accessibility buttons and ADA accessible signage for restrooms across campus; and

**Whereas;** the 2025-2026 Student Welfare Committee charges the upcoming Chairperson(s) with the task of ensuring that this initiative is ongoing until completion; and

**Whereas;** the 2025-2026 Student Government Association commends the work of this administration and tasks the upcoming administration with continuing communication with UNA Facilities and ensures that these initiatives strive towards the betterment of campus for current and future generations of students; and

**Therefore**, be it resolved that the University of North Alabama Student Government Association and Student Welfare Committee expresses gratitude to all of those within UNA Facilities and the UNA Disability Support Services office for their assistance with these initiatives and that the Student Government Association will continue to recognize the importance of accessibility on campus to all students; and
